## Introduction to Motivational Interviewing

**Course Description.** During this face-to-face course, faculty will explain the typical steps people follow when they change a behavior and how to best work with offenders in each step. Faculty will introduce some key concepts of Motivational Interviewing, an approach that accesses the offenders internal motivation for change rather than using external pressure.
